

Privacy Policy

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, BTLCC may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. Use of your Personal Information

Sharing Information with Third Parties

BTLCC does not sell, rent or lease its customer lists to third parties.

All such third parties are prohibited from using your personal information except to provide these services to BTLCC, and they are required to maintain the confidentiality of your information.

Automatically Collected Information
